

## PRODUCT USE GUIDE FOR BACTERICIDAL MULTIPURPOSE CLEANER A19

### Product Description

A high performance product providing an excellent standard of cleaning, degreasing and disinfection. Designed for a wide variety of applications, including the cleaning of floors, walls and equipment, and for the interiors of food delivery vehicles where a high standard of cleaning and disinfection is required.

### Product Features

- May be used neat on ovens to remove baked-on carbon deposits and fats, or may be diluted and used in floor scrubbers where residual antistatic properties protect from the risk of static shock. Highly effective through all forms of foaming equipment and produce a very rich clinging foam. May also be diluted up to 200 times when used through high-pressure washers, even in hard water areas. When used at up to 1 to 50 it is also an effective bactericide.
- Passed BSEN1276. Effective against MRSA, listeria monocytogenes and salmonella typhimurium after 5 minute contact time and Escherichia coli, pseudomonas aeruginosa, staphylococcus aureus and enterococcus hirae at 20°C after 5 minutes contact time.
- It has also been tested under BSEN1276 and found to kill 99.9% of germs within 30 seconds.
- Has also passed the BS5929 (1984) Triangle Taint Test, and therefore is non-tainting to foodstuffs and safe for use where food is processed.
- Regulation (EC) No 396/2005 Maximum Residue Levels. The biocide in this product (Benzalkonium Chloride) has an MRL of 0.1ppm. And therefore food preparation surfaces must be rinsed thoroughly with clean water after disinfection.

### Direction for Use

**Note: Use biocides safely. Always read the label and product information before use.**

- Wash floors and walls using a clean mop, then rinse with clean water and allow to dry. Rinse out mop.
- May be diluted up to 200 times when used through a high-pressure washer, even in hard water areas.
- When used at up to 1 to 50 it is also an effective bactericide.

### Storage

- Store in cool conditions away from direct sources of heat
- Avoid extremes of temperature
- Do not allow to freeze
- Ensure the cap is tightly fitted after use
- Keep out of reach of children

### Shelf Life

- Shelf life 24 months, if stored as recommended.
- Use within 6 months of opening.
