

## PRODUCT USE GUIDE FOR RINSEAID A8

### Product Description

To be used in conjunction with all Cleenol Washaids and Glasswash Detergents through built in or external auto dosing equipment. Ensures the rapid drying of crockery and glassware to a streak-free, sparkling finish, and prevents spotting.

### Product Features

- The product is added to the final stage of the cycle
- The product contains an anti-scaling agent to help prevent the build-up of scale in the rinse section.
- Biodegradable to EU standards.

### Direction for Use

- Will be dosed into the washer by the automatic dosing system at the required operating temperature.
- If dosing manually using the 500ml pack size, add to machine reservoir using machine manufacturer's instructions.
- Use rate is dependent upon water hardness and will be set by our engineers at approximately 0.5-1ml product per litre of rinse water.

### Storage

- Store in cool conditions away from direct sources of heat
- Avoid extremes of temperature
- Do not allow to freeze
- Ensure the cap is tightly fitted after use
- Keep out of reach of children

### Shelf Life

- Shelf life 24 months, if stored as recommended.
- Use within 6 months of opening.

### Environmental

- Do not allow large quantities of neat product to enter surface waterways.
- This product uses recyclable packaging. The chemicals used in the formulation dissociate into ions which are rendered harmless to the environment during the effluent treatment process.
- It contains no Phosphates, NTA or EDTA.
